KARDELEN PAINT AND CHEMICAL INDUSTRY TRADE LIMITED COMPANY WEBSITE INFORMATION COMMUNICATIONS

Kardelen Paint and Chemical Industry Trade Limited Company respects and values the security and privacy of your personal data. Therefore, the acquisition, processing, storage, transfer (when necessary), and confidentiality of your personal data are carried out in accordance with the law.

To protect your personal data, we take the highest possible level of administrative, technical, and legal measures within the framework of the KVKK (Turkish Personal Data Protection Law), GDPR, and secondary legislation. Our aim is to inform you in the most transparent way possible about how your personal data is collected, the purposes of processing, the parties with whom it is shared, and your rights, within the scope of our legal obligations and customer satisfaction.

This privacy policy, prepared by Kardelen Boya, aims to provide the necessary information to data subjects in accordance with the provisions of the Personal Data Protection Law No. 6698 (KVKK) and the European General Data Protection Regulation (GDPR).

This Privacy Notice primarily concerns;

a) Kardelen Boya (the Company) <http://www.kardelenboya.com.tr/> what types of personal data the website (Site) collects and for what purposes it uses the collected personal data,

(b) This explains your rights regarding the data processed by the company and how you can exercise those rights.

In order to better serve you, our visitors, to manage and complete your communication, request and job application processes, to strengthen the security of the Site, and to fulfill our legal obligations arising from relevant legislation, including the Law No. 5651 on the Regulation of Publications Made on the Internet and Combating Crimes Committed Through These Publications, the Law No. 6563 on the Regulation of Electronic Commerce, the Turkish Penal Code No. 5237, the Law No. 6698 on the Protection of Personal Data and the secondary legislation of related laws; your IP address, Internet service provider, operating system name and version, browser name and version, date and time of your visit, pages you visited, your location and the unique identifier of your mobile device, and data that directly or indirectly identifies the visitor if you contact us through our website, are processed by us subject to the principles and conditions set forth in the KVKK (Personal Data Protection Law).

Our legal basis for processing your personal data is: your explicit consent, which we may request from time to time; the laws explicitly listed above and our other legal obligations; the contractual relationship we have established with you, provided it is directly related to the performance of the contract; and, at times, our legitimate interests, provided that it does not harm your fundamental rights and freedoms.

Your personal data may be shared from time to time with our direct/indirect shareholders, affiliates and/or subsidiaries under contractual agreements to provide services for the purpose of conducting our company's operations.

The funds we receive may be transferred to organizations we cooperate with and other third parties within the limits of legality.

A. Security and Privacy

In line with our company's commitment to the protection of personal data and ensuring data security, and pursuant to Article 12 of the Personal Data Protection Law (KVKK);

- To prevent the unlawful processing of personal data,
- To prevent unlawful access to personal data,
- All necessary technical and administrative measures are taken to ensure an appropriate level of security for the protection of personal data.

Kardelen Boya undertakes to take all necessary physical, technical, and administrative measures and to exercise due diligence to ensure the privacy and security of your personal data. Despite Kardelen Boya taking the necessary information security measures, in the event that personal data is damaged or falls into the hands of third parties as a result of attacks on the Site and system, the company will immediately notify you and the Personal Data Protection Board and take the necessary measures.

Kardelen Boya may make changes to its Privacy Policy at any time. These changes will take effect immediately upon the publication of the revised terms and/or policies on the Site. In the event of such a change, our valued customers and business partners will be informed accordingly.

B. Your Rights as a Data Subject

a. Right to Information: You have the right to learn whether your personal data is being processed by our Company, and if so, to request information about the types of data being processed, as well as the purpose of the processing of your personal data and whether it is being used appropriately for that purpose.

b. Right to Correction: You may request the immediate correction of any inaccurate data processed by our company concerning you. You may also request the completion of incomplete data, taking into account the purpose of data processing. c. Right to object to adverse consequences arising from the processing of personal data through automated systems.

c. Right to Erasure (Right to be Forgotten): You may request the immediate deletion of your collected personal data under the conditions stipulated in Article 7 of the Law on the Protection of Personal Data if: the data is no longer necessary for the purposes for which it was collected or processed; you withdraw your consent on which the processing activity is based and there is no other legal basis for the processing activity; you object to the processing activity and there is no overriding legitimate reason for the processing activity as foreseen in the legislation; the personal data has been processed unlawfully; or the deletion of personal data is necessary to comply with a legal obligation to which our Company is subject.

d. Right to Request Restriction of Data Processing: You may request that our Company restrict the processing of your personal data if any of the following situations apply:

(1) if the data subject objects to the accuracy of the personal data, for a period of time during which the data subject can verify the accuracy of the personal data; (2) if the processing activity is unlawful and the data subject objects to the deletion of the personal data and requests instead that the use of the data be restricted;

(3) Our company no longer needs personal data for its processing purposes, but the data subject needs the data for the purpose of making, enforcing or defending legal claims; (4) The data subject objects to the processing activity in accordance with Article 11 of the KVKK until it is verified whether the legitimate grounds of our company outweigh the legitimate grounds of the data subject.

e. Right to Data Portability: You have the right to access the personal data collected and processed by us about you in a structured, updated, and machine-readable format. You may also request the transfer of such data to another data controller without hindrance, or, if technically possible, request that the transfer be carried out by us. The transfer will be carried out if the data processing activity is carried out with your consent or as per a contract and is processed using automated methods. However, this rule does not apply only to data kept in paper form. f. Right to Withdraw Consent: You may withdraw your consent at any time if the data processing activity was carried out solely with your consent.

However, in this case, the legitimacy of data processing activities carried out until you withdraw your consent will not be compromised.

g. Right to Complaint: If you wish to file a complaint or if you believe that our Company has not adequately handled your requests regarding your personal data, you may apply to the Personal Data Protection Board established under the Law No. 6698 on the Protection of Personal Data. As a Data Subject, you acknowledge and agree that if you make a request that results in the Company being unable to use any of your personal data, you may not be able to fully benefit from the functionality of the Site, and you will be solely responsible for any consequences arising therefrom.
